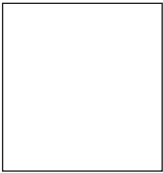

DEEPLY AFFORDABLE HOUSING

- ✓ Prioritize and expand low-income options and affordable units for rent by mandating family-size units in new rental properties that are seeking government assistance.
- ✓ Increase rent control protections. Apply rent control measures to buildings built after 1975 to increase housing availability and keep prices down.

WORKFORCE HOUSING

- ✓ Create dedicated funding focused on the development of workforce housing to subsidize affordable housing options for low- to moderate-income workers so they can remain in the District.

AGING IN PLACE

- ✓ Invest in and strengthen programs to allow long-time homeowners to age in place comfortably and remain in our ward.
- ✓ Focus on opportunities to reduce the tax burden for seniors and families.

NEW HOMEOWNERS

- ✓ Expand programs for first-time homebuyers to make ownership a reality for people at all income levels and capacities.
- ✓ Develop tools and dedicated funding to support, preserve, and improve Black homeownership in the District and across our ward.

PROGRESSING IN HOMEOWNERSHIP

- ✓ Support programs designed to help current homeowners to "step up" by buying their next home in the ward and remain a part of our community.

HOUSING SECURITY

- ✓ Expand inclusive and equitable housing opportunities for groups experiencing barriers to housing, including the LGBTQ+ community and returning citizens.
- ✓ Increase funding for the Emergency Rental Assistance Program to meet the actual needs of residents and protect our most vulnerable.
